Methods of Payment:

We accept Visa, Master Card, Discover, American Express and Check Payments, issued by an US bank. The funds need to be cleared first and credited to our account, before any shipment. Your credit card will be charged at time of ordering

The shipping - insurance charges for Wholesale customers will be applied at time of shipping.

Pricing:

All prices are subject to change without notice. Possession of the wholesale information does not constitute an offer. Manufacturer Suggested Retail Price (Retail Price) is not to be discounted for non-discontinued/active items.

Back Orders:

Backordered items will be shipped as they become available from the manufacturer, unless otherwise advised. Back orders will include shipping charges. Partial shipments will not be considered a valid reason for returns.

Cancellations:

Orders may be cancelled no less than four weeks prior to shipping date by providing written notice.

Shipping:

All orders will be shipped F.O.B. Brush, Colorado 80723. All domestic shipments will be shipped via the United States Postal Service (USPS). Shipping and handling charges will be applied to your order. No deductions are allowed for freight charges. Orders may be subject to an additional insurance fee.

Refused Shipments:

Customer will be responsible for all shipping charges. A 15% restocking and handling fee will apply.

Returns & Claims:

- 1) All returns or claims must be made within 10 days of receipt of merchandise by contacting the returns department.
- 2) A Return Authorization Number (RA#) is required for all returns and must be clearly indicated on the shipping label.
- 3) Returns must be shipped within 15 days of issuing the RA#.
- 4) Any merchandise returned after 15 days of issuing the RA# or merchandise returned without RA # will be refused.
- 5) A 15% restocking and handling fee will apply to all returned merchandise.
- 6) All returns must be in good condition, in their original package with all tags attached.
- 7) Laundered, worn or soiled merchandise will not be accepted.
- 8) A credit will be issued for future orders. No refunds.
